Gilbert, III, Vice Chairman, Miami-Dade County Board of County Commissioners is a graduate of Florida A&M University and the University of Miami School of Law, where he graduated with honors. #### Collaborating to Combat Climate Change and Save Biscayne Bay

#### 9:00 a.m.- 10:15 a.m.: Concerto Ballroom B Collaborating to Combat Climate Change and Save Biscayne Bay

The discussion will focus on how to build resilient communities by working together to address sea level rise and flooding through neighborhood-level planning, mitigate the effects of climate change through the expansion of electric vehicle infrastructure and solar energy, and protect our communities from extreme heat through resilient infrastructure like green spaces. Panelists will also discuss opportunities to partner on lowering nutrient pollution entering waterways and Biscayne Bay through septic-to-sewer conversions, stormwater management, fertilizer bans, environmental stewardship initiatives, and more.



James Murley currently serves has Chief Resilience Officer (CROs) for Miami-Dade County. In that position he leads the 7th largest County in the United States in sustainability and resilience issues. He leads the Office of Resilience focusing on energy efficiency and conservation actions and addressing the impacts of sea level rise. He has spent over four decades working on public policy issues important to Florida. He was also the founding Executive Director of 1000 Friends of Florida, a statewide not-for-profit focused on sound community planning and protection of natural resources. He also helped author sections of the 2014 National Climate Assessment and serves on several county level Task Forces focusing on energy and climate issues.



Crystal Wagar is a Miami Shores Village Councilwoman and Partner at LSN Partners, LLC. Crystal is a well-respected attorney and advocate. She has a wide range of experience in both the public and private sectors. Crystal's public sector experience includes general counsel for the Black Economic Development Corporation, interim city manager for the Village of El Portal, and chief policy aide and chief of staff to former Miami-Dade County Commissioner Jimmy Morales. In the private sector, Wagar worked at two prominent South Florida law firms prior to opening her own boutique advocacy firm, the Connor Group Miami. In late 2013, Crystal moved to Singapore where she spent nearly four years representing the United States in her role as spouse to the United States Ambassador. In April of 2019, Crystal was elected as Mayor of Miami Shores. She also made history as the first African American woman ever elected in the Village's 89-vear existence. Crystal graduated from Temple University and received her law degree from William Mitchell College of Law. Wagar is a current member of the national African American Mayors Association (AAMA). Crystal was named one of South Florida's 50 most powerful and influential black business leaders of 2012, received the Thurgood Marshall Distinguished Young Leader Award, the South Florida Women Extraordinaire Award and named a Miracle Maker by Big Brothers Big Sisters of Greater Miami. Crystal is currently on the Board of Miami Children's Museum, and on the Executive Board of the Miami-Dade County League of Cities.

#### **Tackling the Housing Affordability Crisis**

The panel will explore both short-term and long-term solutions to the affordability crisis. The discussion will cover financing for workforce housing programs, leveraging existing programs to provide relief to residents, interlocal coordination on housing and land use, and addressing affordability more broadly as it relates to accessible transit.

Crystal's public sector experience includes general counsel for the Black Economic Development Corporation, interim city manager for the Village of El Portal, and chief policy aide and chief of staff to former Miami-Dade County Commissioner Jimmy Morales. In the private sector, Wagar worked at two prominent South Florida law firms prior to opening her own boutique advocacy firm, the Connor Group Miami. In late 2013, Crystal moved to Singapore where she spent nearly four years representing the United States in her role as spouse to the United States Ambassador. In April of 2019, Crystal was elected as Mayor of Miami Shores. She also made history as the first African American woman ever elected in the Village's 89-year existence. Crystal graduated from Temple University and received her law degree from William Mitchell College of Law. Wagar is a current member of the national African American Mayors Association (AAMA). Crystal was named one of South Florida's 50 most powerful and influential black business leaders of 2012, received the Thurgood Marshall Distinguished Young Leader Award, the South Florida Women Extraordinaire Award and named a Miracle Maker by Big Brothers Big Sisters of Greater Miami. Crystal is currently on the Board of Miami Children's Museum, and on the Executive Board of the Miami-Dade County League of Cities.



Shlomo Danzinger was elected as mayor of the Town of Surfside in March of 2022. His campaign focused on condo safety, responsible development, pedestrian safety, and responsible government. As mayor, Shlomo Danzinger was determined that the memory of the 98 souls lost during the collapse of the Champlain Towers South nine months prior would not be forgotten. Days after the election, Mayor Danzinger directed the commission's focus to actions that would serve to honor the 98 souls. Mayor Danzinger continues to serve his constituents, focusing on residential safety, new capital projects, and sustainable growth for Surfside.



Christia E. Alou, Esq. is El Portal's Village Manager. Ms. Alou is a government relations professional with over 30 years of experience leading government agencies and departments, as well as legislation, public policy and public affairs for agencies and organizations such as the Congressional Hispanic Caucus Institute, the Ohio Civil Rights Commission and the District of Columbia Mayor's Office on Latino Affairs. In 1991, Ms. Alou graduated from Howard University in Washington, DC, where she received her Bachelor of Arts degree in Broadcast Journalism with a minor in Spanish. While working for the Congressional Hispanic Caucus Institute on Capitol Hill, Ms. Alou attended the University of Maryland School of Law evening classes, graduating in 1996. Upon graduation, Ms. Alou worked on Capitol Hill for several years with the law firm, Verrill & Dana, LLC. She was drawn back into the public sector in 2002, when she was appointed by Mayor Anthony Williams as the Executive Director of the Mayor's Office on Latino Affairs for the District of Columbia. Ms. Alou moved to Miami, Florida in 2006 for a change of pace and to start her family. She resides in Miami Shores. Ms. Alou is a strong proponent of the Arts and STEAM programs for children. Ms. Alou served on the Board of Directors for the Adrienne Arsht Center for Performing Arts for many years and is the Arts Facet Chairperson and member of the Miami-Biscayne Bay Chapter of The Links Incorporated.
