Summarized Minutes

February 1, 2024 City of Aventura Hilton Aventura

On behalf of President Rodney Harris, Mayor of the City of Miami Gardens, 1st Vice President Karyn Cunningham, Mayor of the Village of Palmetto Bay, began the meeting by thanking everyone for being in attendance at the League's February 1st Board of Directors' Meeting On behalf of President Harris and the Executive Board, she thanked the City of Aventura, City of Sunny Isles Beach, and Town of Golden Beach for hosting the League's Board Meeting. MDCLC 1st Vice President Cunningham, called the meeting to order at 8:03 P.M.

The City of Aventura Honor Guard was called to conduct the presentation of colors. The Pledge of Allegience was lead by Ronald Wasson, Manager, City of Aventura. Cameron Wheeler performed the National Anthem and the invocation was conducted by Rabbi Rosenfeld of Aventura Chabad South.

1st Vice President Cunningham asked for a motion to approve the minutes and consent the agenda. The motion passed by a unanimous vote.

1st Vice President Cunningham welcomed the two Mayors of the sponsor municipalities, Mayor Glenn Singer, Town of Golden Beach, Mayor Howard Weinberg, City of Aventura, as well as Commissioner Jerry Joseph, City of Sunny Isles Beach, to the podium to provide the host municipal presentations.

Mayor Singer thanked his neighboring cities for their collaboration in cohosting the Board Meeting with his municipality. He also extended his appreciation to the administration and commissioners of the Town of Golden Beach for their constant hard work and dedication. The Town of Golden Beach is currently transitioning to a new civic center, a state-ofthe-art complex slated to accommodate the town's administrative staff, the Golden Beach Police Department, and its building department. This modern facility will feature an entertainment room for social gatherings and an emergency hurricane command center designed to withstand category 5 storms. By the end of this year, the Town of Golden Beach anticipates the completion of a new public park and wellness center. Despite its small size, the Town of Golden Beach successfully executes all of these projects through effective teamwork among its staff. Mayor Singer also expressed his thoughts and that of his community's regarding Form 6, particularly its implications for smaller municipalities. He views it as an invasion of privacy, given the challenges smaller towns face in recruiting election candidates. Mayor Singer called for the support of likeminded municipalities to align with the Town of Golden Beach's stance.

Mayor Howard Weinberg was welcomed to the podium and expressed his gratitude towards hosting one of the League's Board Meetings. He thanked all of the attendees from the City of Aventura for their contributions to the city's endeavors. During his 14 months as Mayor, he has already cut over 20 ribbons signifying the inauguration of various projects in the city. He then presented a video highlighting the City of Aventura's growth and evolution over the years. Mayor Howard Weinberg touched upon an ongoing collaboration with Hero Housing, aimed at providing luxury apartments to teachers and police officers at a 50% reduced rent rate. He concluded after the video was played by thanking the City of Sunny Isles Beach and Town of Golden Beach for cohosting the Board meeting.

Lastly, Commissioner Jerry Joseph proudly highlighted the recent accreditation of the city's police department, city manager, and award-winning finance department. Currently, the city is in the process of developing a new public tennis court and cultural center. He expressed gratitude to all attendees from the City of Sunny Isles Beach for their role in the city's achievements.

Executive Director Richard Kuper thanked the three sponsoring municipalities for their collaboration in co-hosting this month's Board Meeting. He also thanked City Manager Ron Wasson, City of Aventura, Assistant City Manager Bryan Pegues, and the City of Aventura for their hard work in the planning this meeting. Mr. Kuper emphasized the importance of attendees utilizing these meetings as a platform for information sharing and mutual learning and that by doing so, municipal leaders can gain insights on the developments that are currently occurring

across Miami-Dade County and foster unity. Mr. Kuper proceeded to invite Commissioner Michael Stern, City of Aventura to make a presentation on Colorectal Cancer Month.

Commissioner Michael Stern stated that as a survivor of stage 4 colorectal cancer wanted to inform the audience that March is now designated as Colorectal Cancer Month. Despite being one of the most neglected forms of cancer, he highlighted the rising prevalence of colorectal cancer cases, noting that a significant portion of funding from Washington D.C. is typically allocated to breast cancer research. Commissioner Stern informed those in attendance of his upcoming meeting with policymakers in Washington D.C., where he plans to advocate for increased funding for colorectal cancer research. He asked each city to issue a proclamation. He emphasized that having the support of every city in the largest county in Florida would strengthen his case for increased funding during his discussions in Washington D.C. Commissioner Michael Stern then thanked the League for giving him the opportunity to speak about this issue.

Attorney Robert Meyers from Weiss Serota Helfman et al. was welcomed to the podium to provide further insights into Form 6 and its litigation procedures. Prior to joining Weiss Serota Helfman, Mr. Meyers served as the director of the Miami-Dade Commission on Ethics and Public Trust for 13 years. Drawing on his experience, he aimed to educate the audience about public corruption investigations and the detection of conflicts of interest. Mr. Meyers emphasized that Form 6 lacks any substantial information that could help the Commission on Ethics and Public Trust in identifying conflicts of interest or corruption beyond what is already disclosed in Form 1. Due to ambiguities in federal and state constitutional provisions, attorneys at Weiss Serota Helfman concluded that Form 6 is excessively invasive and should not be applicable to local government. Consequently, they intend to initiate legal action against its implementation. He asked if any municipality was interested in being part of the case to please contat him, Jamie Cole or Susan Trevarthen at the offices of Weiss Serota Helfman Cole & Bierman

I. Background:

Commissioner Melissa Castro was elected to the Coral Gables City Commission in April 2023. Thereafter, she sought guidance regarding the application of the Miami-Dade County Conflict of Interest and Code of Ethics Ordinance, Section 2-11.1, Miami-Dade Code, (county ethics code) to her private employment as the principal in a construction permit expediting company that does business in Coral Gables.

Since that time, Ethics Commission legal staff has had several discussions with Ms. Castro, Coral Gables municipal counsel, and other members of municipal bar, regarding the limitations and prohibitions imposed by the county ethics code on local elected officials who provide professional services to clients in their own cities.

A draft ethics opinion provided by the Ethics Commission's legal staff in this matter concluded that Ms. Castro would not be able to operate her business in the City of Coral Gables in the same manner as she has in the past. The guidance would not only have impacted Ms. Castro's private employment but also affected other similarly situated local elected officials. Thus, constituting a matter of great public importance, formal guidance is sought from the Ethics Commission. ¹

Also, consistent with the Ethics Commission's practice in these matters, Ms. Castro, her attorneys, and members of municipal bar have been invited to present to the Ethics Commission as regards this proposed formal opinion.

Her company assists clients with a variety of engagements with local government, including some that require only ministerial official action on the part of city staff. For example, MED assists clients with filing or recording documents with local governments, filing direct representative notices with local governments when property or business owners are out of the jurisdiction or are otherwise not able to invest time in construction permitting procedures, or registering licensed contractors with all the required accompanying documents such as state and local licenses, and certificates of liability or workers compensation insurance.

MED also assists clients in engagements with local government that require discretionary official action by city staff. These include seeking revisions to previously issued building permits, legalizing un-permitted construction subject to legal sanctions including notices of violations and stop-work orders, as well as securing certificates of completion and occupancy. ²

Because her company represents clients in Coral Gables, then it is contemplated that she or her employees will interact with city staff.

V. <u>Legal Analysis</u>:

The county ethics code establishes the minimum standard of ethical conduct and behavior for municipal officials. ³

a. Conflicting Employment and Prohibited Appearances and Payments

The county ethics code prohibits conflicting employment defined as private employment which would impair the independence of judgment in the performance of public duties. Also, the code prohibits making a presentation before a city board or agency on behalf of a third party with respect to a "license, ruling, decision, opinion or other benefit." Not only is the presentation disallowed, but so is the receipt of any compensation, directly or indirectly, in any form, for services rendered to the third party in relation to the municipal benefit sought. ⁴

Consequently, while municipal officials may have private employment in their city, may represent clients in their city, and may even be allowed to interact with the city on behalf of clients in very limited scenarios, these two provisions impose significant restrictions on private employment.

Private employment involving pure informational interaction with municipal staff on behalf of clients that only requires ministerial official action may be permitted. Any employment that

b. Exploitation of Official Position & Official Actions

A city commissioner may not use his or her official position to secure special benefits, privileges or exemptions for themselves or others. Consequently, even when interacting with city staff as part of a purely ministerial transaction related to outside employment duties, the official may not represent themselves as a commissioner. Of course, the official is not permitted to use city staff or resources to support outside employment and should refrain from giving city employees any direct or indirect instruction to engage on any matters involving their private employer or clients. Finally, an official cannot use his or her public position to promote the use of a private employer's services and should avoid suggesting to current or future clients that they will receive preferential treatment from city staff as a benefit of his or her public position. ⁸

c. Voting Conflicts

The county ethics code's voting conflict provision prohibits voting or participating on a matter if the official "would or might, directly or indirectly, profit or be enhanced by the action." It is stricter that the state ethics code's standard that limits a municipal officer from voting upon any measure "which would inure to his or her special private gain or loss." ⁹

Consequently, if there is any matter that comes before a city commission that may affect a voting official's employer, company, or one of its clients, then a voting conflict will require recusal. ¹⁰

conflict cannot be mitigated simply because another member of the officer's firm engages in the representation before the public board, because the concern is the potential loss of objectivity a public officer may have if his firm is attempting to influence the decisions of his board. This concern remains present so long as the officer's firm is representing a client on a matter of his board, even if he is refraining from personally advising the firm or its client about the matter.); CEO 12-9 and CEO 03-7 (Recusal from voting on the matter and compliance with voting conflict statute found at Section 112.3143(3)(a), Florida Statutes, does not negate the prohibited employment conflict because the two statutes operate independently.)

However, there are several provisions of the county ethics code that limit or otherwise prohibit her communications or interactions with municipal staff in her capacity as the owner and chief executive officer of a permit expediting firm that does business in that city.

More specifically, neither she nor her company may have contacts with city staff on behalf of a client, if the contact will require decision-making by municipal staff on a discretionary matter such as whether to grant a waiver, permit, variance, certificate, ruling, opinion, decision concerning violations of the city's code or ordinances, or any other benefit. Moreover, she may not receive any compensation, directly or indirectly, from a client that seeks this type of relief from the city.

She is additionally prohibited from using her official position or any city resources to support her private employment and she may not suggest to current or future private clients that her public position will afford them unique or special treatment from the city.

She may not vote or participate in any measures before the Coral Gables City Commission that may affect her private company or any of its clients.
